

CORE ESSENTIALS WEBSITE TERMS OF USE

These terms and conditions of use (the “Terms of Use”) apply to the websites owned or operated by Core Essentials, Inc. (“CE”), including without limitation coreessentials.org, (each individually, an “CE Site” and collectively, the “CE Sites”). The CE Sites are the property of CE and its licensors. **BY USING AN CE SITE, YOU AGREE TO THESE TERMS OF USE; IF YOU DO NOT AGREE, DO NOT USE ANY CE SITE.**

Subject to your compliance with these Terms of Use in effect at the time of your visit to the CE Site, CE grants you a personal, non-exclusive, non-transferable, limited privilege to enter and use the public areas of the CE Sites. In the event of any controversy or dispute between CE and you arising out of or in connection with your use of the CE Sites, the parties shall attempt, promptly and in good faith, to resolve any such dispute. If we are unable to resolve any such dispute within a reasonable time (not to exceed thirty (30) days), then either party may submit such controversy or dispute to mediation. If the dispute cannot be resolved through mediation, then the parties shall be free to pursue any right or remedy available to them under applicable law.

Void Where Prohibited
